MEMBERSHIP APPLICATION & DECLARATION

Conditions of Membership.

1. **“MCC”** means & includes Mosman Cricket Club Incorporated & its respective directors, officers, members, servants or agents.
 2. If accepted I will be a member of MCC for the 12 months commencing on 1 September.
 3. I declare that I have advised MCC if I am not an Australian citizen or permanent resident and I agree to provide evidence of identity as required in order to comply with rules regarding Overseas Players;
 4. I agree to pay the membership fees for the season in full.
 6. Insurance is in place that provides limited cover to me whilst I am performing or participating in any authorised or recognised MCC activity (“MCC Activity”) approved by bodies duly operating competitions under Cricket NSW, or other matches organized by the club, and associated practice activities. *(For insurance details contact the Secretary.)* I can, in my own interests obtain personal insurances in addition to the cover provided through Cricket NSW
 7. I agree be bound by the terms of the MCC Constitution & by any rules or protocols made by MCC.
 8. Release & Indemnity: In consideration of accepting my application for membership I:
 - a) Agree to abide by the Sydney Cricket Association rules and recommendations on Protective Equipment
 - b) Indemnify & hold harmless MCC in respect of any Claim by any person including but not only another Member of the MCC arising as a result of, or in connection with my membership &/or participation in any MCC Activity.
 - c) Agree that I will not hold MCC responsible for any injury or accident I may suffer as a result of taking part in a match, or attending practice activities conducted by MCC and that I will not make any claim or take any action against MCC to recover any loss or expense incurred by me as a result of any such injury or accident;

In this clause 8 “Claim” means & includes any action, suit, proceeding, claim, demand, damage, penalty, cost or expense however arising but does not include a claim in respect of any action, suit, etc made by any person entitled to make a claim under a relevant insurance policy or under the Constitutions or Regulations of the MCC and Cricket NSW related bodies.
 9. Fitness to Participate: I declare that I am medically and physically fit & able to participate in any MCC Activity. I am not & must not be a danger to myself or to the health & safety of others. I will immediately notify MCC to the Club Secretary or GM – Cricket of any change to my fitness & ability to participate. I understand & accept that MCC will continue to rely upon this declaration as evidence of my fitness & ability to participate.
 10. I declare that I have no outstanding financial obligation to any previous club, and I am not listed with Sydney Cricket Association as a defaulter to any affiliate of Cricket NSW.
 11. I acknowledge that the information that I have provided is necessary for the Objects of MCC. I acknowledge and agree that information will be disclosed to the Sydney Cricket Association, Cricket NSW and Cricket Australia and will only be used for the Objects of MCC and to provide me with membership services. I acknowledge that Cricket NSW and Cricket Australia may utilize the information for its purposes. I understand that I will be able to access my information upon request.
 12. I acknowledge that the benefits, advantages, privileges & services provided by MCC includes MCC sending to me marketing and promotional material from MCC and from the official sponsors of MCC. I give MCC permission to use the information that I have provided for this purpose.
 13. I acknowledge and accept the rules of the club relating to behaviour as a member and agree to uphold both the intent and spirit of those rules at all times.; and I will abide by the Sydney Cricket Association’s Code of Conduct including but not limited to “The Spirit of Cricket”.
 15. I acknowledge having read, and agree to the above terms including the release & indemnity.
